## **POLICIES:**

- By sending in deposit and entry, you agree to comply with NATRC rules and facility rules set up by ride management.
- Payment in full must be submitted with entry form and signed liability waivers.
- Make check payable to Gila Chapter BCH.
- No entries accepted after October 16, 2020.
- Riders must provide cancellation notices to the ride secretary prior to October 16, 2020 to qualify for a refund.
- After October 16, a \$20 administrative fee will be subtracted from the refunded amount.
- No refunds for “no shows.”
- All riders must sign three waivers (New Mexico, NATRC, and NAN Ranch) and return by mail with entry form.
- In addition, junior riders must submit a liability waiver signed by parent or guardian. Waiver must be submitted with entry form.
- Out of state competitors must present an original or electronic proof of current negative Coggins test for each equine.
- If crossing state lines, competitors must bring an equine health certificate and any other documents required by the state(s) through which they travel.
- New Mexico entrants: Remember your hauling papers!
- All Juniors are required to wear an ASTM/SEI, Snell, or approved riding helmet when mounted on any equine at any time.
- Juniors may ride in weight classes in Open and Novice Divisions if they meet the weight requirements.
